Report Submitted: From 10/1 - 10/31 the Fire Department ran a total of 265 calls with 54 being fire related. 186 EMS calls and 25 Other calls. There was a small bedroom fire at

14138 S. School St. Inspectional Services conducted 816 inspections, 5 permits were issued, and 69 tickets were issued. Grass season has been completed but still working on the bushes on the abandoned properties. Regarding demolitions: we executed a deed in lieu agreement and now the Village owns 503-511 W. 136th Street. After asbestos is abated will move forward with demolition. Platinum 144 has been demolished. Grass seed has been put down. Chief Smith is looking to go to another reporting system instead of "NIFRS". The cost savings would be approximately \$3,000 for 1st year
