Village Administration

<u>Finance Director – David Gonzalez</u> – No report.

Fire Dept. / Bldg & Zoning/Inspectional Services Deputy Fire Chief Mick Smith

Report Submitted: From 4/9 to 5/14 the Fire Department responded to 312 calls. 13 – Fire Calls (3 Intown Building Fires) no fatalities, 231 Ems Calls and 68 other calls. Inspectional Services performed 1160 Inspections (Residential, Property Maintenance and Multi-Family), 43 Permits were issued and 35 tickets issued. Grass is being cut at vacant properties. MFD compliance letters have been mailed.

13912 S. Wentworth and 13830 S. LaSalle have been demolished due to code violations. Building Demolition List (Phase I) is for 5 W. 137th St.,19 W. 138th St, 13612 S. State and 13719 S. Atlantic. Revamp Ems fire training.

Superintendent of Public Works - Jerome Russell

Absent, Mayor Jackson stated cold patching and tree trimming is still be conducting.

Mayor Jackson asked Finance Director for an update on the Flood Bros Scavenger service contract. Director Gonzalez stated as of August residential rates for 1 and 2 units would remain the same for the first year. The rate would increase August 2020 by 3% the rate that Flood Bros would charge us. The rate would be about 60¢ more for these units. Regarding the 3 units and more we would be paying Flood Bros based on the contract. We're working with their billing table. We would be looking to add a service fee of about \$1.50 on top of these rates. Rates will be brought before the Board for approval.

Police Department - Deputy Chief Willie Darkried

Report Submitted: Police Department received a check for over \$3,000 for damages by an offender who damaged 2 police cars. Supervisors have been given lists of hot spots. Two officers are in field training. Mayor Jackson asked that the officers control noise levels with the loud music.
