Budget Director - David Gonzalez

Fire Dept. / Bldg. & Zoning/Inspectional Services - Chief Mickil Smith

Report Submitted: From 6/15 - 7/14 - Total Calls 270, Fire related 51, EMS 194 and Other 25. In house ambulance will be in service as of 7/15. Lt. James Muirhead is retiring. Alley tree project beginning soon. CPR Training is forthcoming for residents.

Superintendent of Public Works - Jerome Russell

Report Submitted for month ending 6/30. Public Works is continuing to address residents' complaints. Nicor Gas is continuing with the natural gas main replacement work throughout the Village. ComEd is trimming trees near power lines in East Ivanhoe. 6/13 Spring Cleanup Day was a huge success. The Consumer Confidence Report for 2019 has been completed and submitted is available on Village website. The department responded to 125 Julie locates. Streetlights have been repaired at 13930 S. Indiana, 14201 S. Wabash, 14301 S. Wabash, 14307 S. Wabash, 14214 S. Tracy, 14418 S. State and 14323 S. Atlantic.

Police Department - Chief David DeMik

Report Submitted: Chief DeMik indicated 1/2021 Cook County is narrow banding the radio frequencies and the current radios will not work. Chief DeMik indicated he is researching grants to fund new radios. The 1/2021 may be pushed back due to COVID. We applied for the COPS Hiring Program (CHP). The Village was awarded \$1,046,519 in federal funds. This is 100% for 5 officers for 3 years. Testing for Police Officers will be coming soon. Masks and hand sanitizers are available at the Public Safety Bldg. Numerous tickets were written for the discharge of fireworks. We hope to bring Sgt. Kozeluh before the Board of Trustees on 7/28 to make him Commander for the Police Department.

Clerk Holcomb mentioned Village Stickers are \$33 in July for Seniors 65 and over \$7. Hopefully, we'll be able to have a Shred Day this year.

Village Attorney - Rich Bruen
