IV. Departmental Reports:

A. Village Administration — Finance Director David Gonzalez – Absent

Mayor Jackson allowed Mr. Francois to give a presentation of his interest in wanting to bring a New Orleans type business to the old Broasted Chicken formerly located at 13350 S. Halsted.

B. Building/Zoning Fire Department & Inspectional Services
 Chief Jon Bruce
 Total Fire 346 CALLS – 222 fire responses
 Inspectional Services: boarded up bldgs. as needed; 138 tickets issued & 49 permits issued with total value of \$10,368.

C. Public Works — Crew Leader Jim Horn

Street Sweeper was out daily, meter reads for 2 days, 11 trees trimmed, 25 red tags hung, 4 water main breaks repaired, 24 final reads and 16 high bill appts.

D. Police Department - Chief of Police Willie Darkried

The Police Department has received the first installment of the Attorney General Retail Theft grant in the amount of \$55,000.00. 3 new officers have been hired by the department. Two officers are in the academy and one in early stages of field training.

 - Swearing in of Deputy Fire Chief John Brennan Firefighter/Paramedic Cody Mcelheny This item was moved to the end of the agenda. Village Clerk Holcomb swore them in.
 - Discussion regarding a resolution authorizing the execution of a settlement agreement in case number 2018 cv 2138.
 Atty Morton stated this was discussed.

3. Discussion regarding an ordinance amending Chapter 15.02 adopting building and fire codes for the Village of Riverdale. Chief Bruce stated this brings codes up to date that are 10 years behind.

Atty Morton stated he wanted to include another item and stated there would be no vote taken at this time. He referenced 2 Village owned properties: 165 W. 144th St (Ice Cream/Coffee Shop) and 13601 S. Ashland (Truck Terminal). Both are in TIF Districts. Notice was published and no other bidders.

G. Village Engineer -

- Discussion related to accepting a proposal prepared by Precision Pavement Markings, Inc. for installing pavement marking along 144th street between Stewart Avenue and Atlantic Avenue.
 Engineer Hodges mentioned the lowest bidder was Precision Pavement Markings at \$22,670.80
- 2. Discussion related to approving an intergovernmental agreement by and between the village of Riverdale and the Metropolitan Water Reclamation District of greater Chicago for condition assessment and rehabilitation of sanitary sewers in the Village of Riverdale.
