2. Resident, any member of the resident's household or a guest or other person under the resident's control <b>shall not engage in any act intended to facilitate criminal activity</b> , including drug-related criminal activity, on or esaid premises.
3. Resident or members of the household <u>will not permit the dwelling unit to be used for, or to facilitate</u> <u>criminal activity,</u> including drug-related criminal activity, regardless of whether the individual engaging in such activity a member of the household, or a guest.
4. Resident, any member of the resident's household or a guest, or another person under the resident's control shall not engage in the unlawful manufacturing, selling, using, storing, keeping, or giving of a controlled substance, at any locations, whether on or off the dwelling unit premises or otherwise.

7. In case of conflict between the provisions of this addendum and any other provisions of the lease, the provisions of the addendum shall govern.
