**CONTRACTORS' REGISTRATIONS ARE ISSUED FOR A PERIOD OF ONE YEAR FROM DATE PAID.** Checks are to be made payable to the VILLAGE OF RIVERDALE. You may need to update Surety Bonds, Certificate of Insurance or License if needed throughout that one year period.

All work performed on site shall be subject to inspections by duly authorized personnel of the Village of Riverdale through the Riverdale Fire-Rescue Department: Inspectional Services Division. Prior to performing work on site, check with the Inspectional Services Department at 708-849-1798 regarding the need to secure a permit. ALL PERMITS MUST BE ISSUED BEFORE THE START OF ANY WORK.

For Plumbing Contractors only: Plumbing contractors must provide a certificate of insurance and a copy of your State of Illinois Plumbing license from the Illinois Department of Public Health. You must complete the enclosed application but are exempt from the \$175 renewal fee.

Make sure you obtain a building permit before any work is conducted. No work is permitted in the Village of Riverdale without first securing a building permit. Failure to secure a permit before work begins will result in tickets and fines being issued. It can take approximately 3-10 business day to process a building permit. All building permits go through a process which includes checking ownership of property and any outstanding debt owed to Village by owner. To help expedite the process please make sure the following items are turned in with building permit application:

- Applications must be completely filled out and signed.
- Attach a scope of work, list of material and cost of job (including materials and labor)
- If work is being done for fences, concrete or new structures, please enclose a plat of survey on property.
- New windows require a list of type of windows being installed and the U-valve (U-factor) of the window.
