Simultaneous Petition Filing Lottery Procedures

- 1. Petitions among established political parties for the same offices filed on October 21, 2024 at 9:00 A.M. are deemed filed simultaneously. All petitions filed were for the Democratic Party. The names of the Democratic Party candidates who filed simultaneously on October 21, 2024, shall be listed alphabetically for each office and shall be numbered consecutively starting with number "1," which shall be assigned to the candidate whose name is listed first on the alphabetical list. Candidates who filed as part of a slate shall be given one number per office sought, assigned to the first candidate listed on the slate for each office.
- 2. Petitions among established political parties for the same offices filed within the last hour of the filing period on October 28, 2024 are deemed filed simultaneously. The same procedures above shall be followed for established political party candidates who filed simultaneously on October 28, 2024.
- 3. A simultaneous petition filing lottery is held among Democratic Party candidates who filed simultaneously on October 21 and among established political party candidates who filed simultaneously on October 28.
- 4. Ping pong balls shall be numbered, according to the chart below. Each numbered ball shall be placed in a container and the container shall be thoroughly shaken to mix the balls.
- 5. Balls shall be drawn blindly and at random one at a time from the container by the Deputy Village Clerk for each office and filing time. The drawing shall be open to the public.
- 6. The first ball pulled shall determine the first ballot position; the second ball pulled shall determine the second ballot position; and so forth until all balls have been pulled.
- 7. Candidates shall be certified in the order determined by the procedures outlined above.
