III. Presentation of proposed Appropriation Ordinance

Mayor Jackson recognized Finance Director David Gonzalez. He stated the Village has prepared the Fiscal Year 2022 budget. Copies were provided to Mayor Jackson and the Village Board. Finance Director summarized the budget. In the General Fund we're estimating revenue at \$13,217,415. Property tax makes up about 37.8% of that revenue. We're anticipating gaining \$5,000,000. Intergovernmental Revenue which is our sales tax and income taxes which makes up about 28/9% of the revenue. We're anticipating about \$3,816.700 coming from there. Fines and Forfeitures we're anticipating \$585,500 which is 4.4%. Charges for Services we're anticipating \$683,700 which is 5.2% of the anticipated revenue. Expenditures by departments total \$12,915,740.
