 A RESOLUTION OF THE VILLAGE OF RIVERDALE, COOK COUNTY, ILLINOIS ESTABLISHING A SPECIAL FUND FOR CALUMET SAG TRAIL IMPROVEMENT EXPENSES;

Mayor Jackson referred to Atty Welch he stated Chief Scharnhorst requested that this account be created. Village received grant to pay for its share in the Cal Sag Trail improvements. Funds were currently with Blue Island and are being transferred over. We're creating a separate bank account to deposit the grant funds.

 A RESOLUTION OF THE VILLAGE OF RIVERDALE, COOK COUNTY, ILLINOIS, APPOINTING MICHELLE KELLY-ELLZEY AS INDEPENDENT DIRECTOR TO THE RIVERDALE FINANCE CORPORATION;

Mayor Jackson asked Michelle Kelly-Elzey to introduce herself and her background. She stated she's graduated from University of Illinois with degree in accounting. CPA for 25 years. Background in non for profit and municipal accounting.

Attorney Welch stated we're creating the Riverdale Finance Corporation to refinance some bonds that were issued in 2011 which had an extremely high interest rate. New law allows the Municipalities to create a not for profit corporation which will allow the Village to refinance the bonds at a significantly lower interest rate saving up to \$400,000 annually for first few years. The independent director is one of the members of the corporation and the rating agencies like to see someone one independent of the Village serving on the corporation. That would be Ms. Kelly-Elzey's appointment to serve in this positon.
