9. A MOTION AUTHORIZING THE EXECUTION OF AN ALLEY IMPROVEMENT AGREEMENT WITH RIVERDALE MATERIALS.

Mayor Jackson referred to Engineer Hodges. He stated this agreement is between the Village of Riverdale and Riverdale Materials for improving alleys located between 146<sup>th</sup> St and 145<sup>th</sup> Street east of Wentworth. The agreement will consist of materials being donated by Riverdale Materials for constructing the base of the alleys which will be capped over. Mayor Jackson asked if there were any out of pocket expenses from the Village. Engineer Hodges said there will be. Engineer Hodges stated the reason for the joint effort will be that some of the cost will be covering equipment and the labor to help construct the improvements. Mayor Jackson asked if there would be any CDBG money available for this project. Engineer said not for this phase. Engineer Hodges stated this alley was targeted because it is one of the alleys that appears on the 2017 CDBG grant application. There will be funds used to improve this alley in addition to this pilot program. Mayor Jackson asked if this is a CDBG eligible project. Engineer Hodges said not this project but the area yes. Which would be a Phase II.

Mayor Jackson referred to Finance Director Gonzalez. He asked what the Village's out of pocket expenses would be. Engineer Hodges said the estimated cost would be between \$15,000 - \$20,000 which would cover labor and equipment. Engineer Hodges stated engineering fees probably would be around \$8,000. Mayor Jackson asked why this project couldn't be reimbursed by County grant money. Engineer said it couldn't be. Engineer Hodges said we're approaching the project this way so the Village's dollars can be stretched as far as possible. Engineer Hodges stated if we use the \$250,000 we'll probably only be able to improve one or two alleys because we have to reconstruct the base. Finance Director Gonzalez stated this project cost would be \$20,000 and funds would be coming from Village treasury. Mayor Jackson stated he would like to use CDBG funds in lieu of Village funds. Finance Director Gonzalez stated he yet would budget for \$30,000 for the pilot program for this year.
