1. AN ORDINANCE OF THE VILLAGE OF RIVERDALE, COOK COUNTY, ILLINOIS, AUTHORIZING THE DISPOSAL OF CERTAIN SURPLUS PROPERTY.

Mayor Jackson stated this in in reference to our old garbage cans. He referred to Atty Welch. He stated we're proposing to dispose of cans which have little to no value at this time.

Mayor Jackson referred to Attorney Welch. He stated this was discussed at the Committee of the Whole Meeting. Our code is to be updated to allow businesses to pay the portion of property taxes owed to the Village directly to the Village.

3. AN ORDINANCE OF THE VILLAGE OF RIVERDALE, COOK COUNTY, ILLINOIS, APPROVING A DEED IN LIEU OF FORECLOSURE AND SETTLEMENT AGREEMENT ON THE REAL PROPERTY

Mayor Jackson asked what address this was referencing. Atty Welch stated 507 W. 136th St. Mayor Jackson stated some of the properties in the Pacesetter subdivision aren't compliant with Village code and will be demolished. In this case the Village has a lien on this property. The Village initiated the foreclosure process but owner agreed to deed property over to the Village. Mayor Jackson referred to Chief DeMik. He stated ordinance creates up to 2 commander positions. These positions would help the Deputy Chief and Police Chief with administrative work.

5. AN ORDINANCE OF THE VILLAGE OF RIVERDALE, COOK COUNTY, ILLINOIS, AMENDING THE MUNICIPAL CODE OF THE VILLAGE OF RIVERDALE BY THE ADDITION OF CHAPTER 3.10 IMPOSING A MUNICIPAL CANNABIS RETAILERS' OCCUPATION TAX.

Mayor Jackson referred to Attorney Welch. He stated the State has passed legislation legalizing the recreational use of cannabis effective 1/1/2020. The Illinois Department of Revenue requires a local tax that its required to collect be filed 90 days prior to its effective date. Sales can begin on 1/1/2020
