Mayor Jackon referred to Chief Bruce. He stated that we're down to 1 truck and we've been needing assistance for other towns if fire is in elevated location. Finance Director Ellzey indicted the cost of the truck would be \$23,934.20. Village would be paying for 12yrs starting in September 2025. Mayor Jackson expressed concern about truck passing under viaducts. Per Chief Bruce it'll clear.
