1. An Ordinance of the Village of Riverdale, Cook County, Illinois, amending Chapter 8.04 of Title Eight of the Riverdale Municipal Code providing for regulation of garbage and refuse.

Mayor Jackson referred to Attorney Welch. He stated this ordinance updates the current. He stated traditionally the franchise for garbage collection is single and two unit buildings. This ordinance requires all residential units use Village garbage collection service. It exempts commercial, industrial and any residential that is multiuse. Attorney Welch stated Mayor Jackson's goal is to ensure there's a single point

of contact, set schedule and no concern about garbage not being picked up and overflowing. Franchise takes effect August 1, 2019.

Mayor Jackson referred to Attorney Welch. He stated this is a garbage service contract. He stated the costs are going down to \$19 for single family homes and 2 units. The contract is for 5 years. Flood Brothers will be providing the garbage cans and essentially same schedule of pickup. There will an extra Cleanup day and a biannual electronic recyclable collection day included in the contract.
