

NOTICE, pursuant to Section 2.08.040 of the Village of Riverdale Municipal Code, a special meeting of the Village of Riverdale Board of Trustees is hereby called for December 13, 2024, at 10:30 a.m., in the Village Board Chambers at 157 West 144th Street, Riverdale, Illinois 60827. The special meeting on December 13, 2024 will be for consideration of and action on: (1) the annual tax levy ordinance of the Village of Riverdale for the fiscal year beginning May 1, 2024 and ending April 30, 2025; (2) an ordinance abating the real estate tax heretofore levied for the tax levy year 2024 to pay the debt service on \$12,755,000.00 general obligation bonds, series 2011, of the Village of Riverdale; (3) an ordinance authorizing and approving an amendment to the automatic aid agreement between the Village of Riverdale and other cooperating municipalities regarding fire protection and emergency medical services; (4) an ordinance amending Chapter 17.011 (off-street parking and loading requirements) of the Riverdale Zoning Ordinance regarding off-street parking requirement exemptions (ZBA 24-05); (5) an ordinance granting a conditional use to allow a “beauty parlor” use at 450 W. 144th Street within the B-1 Community Shopping District (ZBA 24-04); (6) an ordinance denying a conditional use to allow a “motor vehicle repair garage” use at 13727 S. Halsted Street in the B-3 General Commercial District (ZBA 24-06); (7) a motion to ratify Resolution No. 2024-22 approving a deed in lieu of foreclosure agreement for 13856 S. Halsted Street; (8) a resolution authorizing the execution of an application for the Cook County Community Development Block Grant 2025 Program Year; (9) a resolution authorizing and approving an agreement with Edwin Hancock Engineering Co. for preliminary and design engineering services on the school street resurfacing project; (10) a resolution authorizing and approving the use of motor fuel tax funds for improvement under the 2024 Sidewalk Replacement Project – Area 1; (11) a resolution authorizing and approving the use of motor fuel tax funds for improvement under the 2024 Sidewalk Replacement Project – Ivanhoe; (12) Approval of the special board meeting minutes dated November 12, 2024; (13) Approval of the regular board

meeting minutes dated November 26, 2024; and (14) Approval of the regular corporate bills prior to the period ending December 13, 2024.
