**A. A RESOLUTION OF THE VILLAGE OF RIVERDALE COOK COUNTY, ILLINOIS, AUTHORIZING THE VILLAGE TO SUBMIT AN APPLICATION AND ENTER INTO AN INTERGOVERNMENTAL AGREEMENT FOR THE CORONOVIRUS RELIEF FUNDS PROVIDED TO COOK COUNTY UNDER THE CORONVIRUS AID, RELIEF AND ECONOMIC SECURITY ACT.**

Attorney Bruen stated Cook County has chosen to allocate \$ 51,000,000 of its CRF funding to 134 municipalities. This authorizes Village President or his designee to submit Cook County Suburban Municipality Application for Coronavirus relief funds.
