A. AN ORDINANCE OF THE VILLAGE OF RIVERDALE, COOK COUNTY, ILLINOIS, AMENDING CHAPTER 15.48 OF TITLE 15 OF THE RIVERDALE MUNICIPAL CODE REGARDING THE POSTING OF PROPERTY OWNER INFORMATION IN MULTI-DWELLINGS.


