You are further notified that the above-designated Municipal Officers Electoral Board for the Village of Riverdale shall meet at 9:30 a.m. on Tuesday, December 13, 2023, at the Village Hall of Riverdale, 157 W. 144th Street, Riverdale, Illinois 60827, for the purpose of hearing and passing upon objections to the nomination papers designated above, and that a CALL has been, and is hereby made, by the Municipal Officers Electoral Board for the Village of Riverdale for said meeting, to be held at the time and place and for the purpose of aforesaid. If you are the objector and you do not appear for the hearing, in person or by counsel, at the above time and place, a default judgment may be entered against you resulting in a finding that the nomination papers are valid. If you are the candidate and you do not appear for the hearing, in person or by counsel at the above time and place, a default judgment may be entered against you resulting in a finding that the nomination papers are invalid and your name removed from the ballot.
