
## FOR SPECIAL BOARD MEETING

### OF THE VILLAGE OF RIVERDALE

NOTICE, pursuant to Section 2.08.040 of the Village of Riverdale Municipal Code, a special meeting of the Village of Riverdale Board of Trustees is hereby called for February 11, 2025 immediately following the Committee of the Whole meeting at 7:00 p.m., in the Village Board Chambers at 157 West 144<sup>th</sup> Street, Riverdale, Illinois 60827. The special meeting on February 11, 2025, will be for consideration of and action on: (1) a resolution withdrawing the Village of Riverdale from participation in the Intergovernmental Combined Dispatch and Communication System Agreement dated November 30, 2004 (E-COM); (2) a resolution withdrawing the Village of Riverdale from participation in the intergovernmental cooperation agreement between E-COM and SOUTHCOM Public Safety Communications to form a Joint Emergency Telephone System and repealing Resolution 2023-37 of the Village of Riverdale concerning the same; (3) a resolution accepting and approving a proposal from Central Dispatch to provide 911 Fire/EMS Dispatch Services; (4) a resolution authorizing and approving an intergovernmental agreement with the Cook County Sheriff's Office to provide 9-1-1 police dispatching services; (5) a resolution authorizing and approving an intergovernmental agreement with the Cook County Emergency Telephone System Board for distribution of 911 surcharge funds; (6) an ordinance authorizing and approving the purchase of a 2019 Ford Expedition for use by the Riverdale Fire Department; (7) an ordinance granting a conditional use to allow a "truck parking area or yard" use at 824 W. 138<sup>th</sup> Street within the I-1 Restricted Industrial District (ZBA 25-01); (8) an ordinance authorizing and accepting the donation of real property commonly known as 526 W. 136<sup>th</sup> Place; (9) a resolution authorizing the execution of an application for the Cook County Community Development Block Grant Program for Program Year 2025; (10) approval of the Special Board Meeting Minutes dated November 12, 2024; and (11) approval of the Regular Corporate Bills prior to the period ending January 24, 2025.
