(Gallagher Asphalt submitted the single proposal for Constructing Improvements. The project was publicly advertised with multiple contractors picking up bid documents. This project will be constructed with funds from The Rebuild Illinois Program)

Engineer Hodges indicated this single bid exceeded engineer's estimate and suggested Village Board reject it implying a no vote. The bid is over the Engineer's estimate of \$125,000.. Gallagher Asphalt's bid was \$183,777
